

CLUB DES TIREURS DE VILLE SAINT PIERRE MEMBERSHIP AGREEMENT

1. OBJECT OF THE MEMBERSHIP:

The MEMBERS have hereby created CLUB DES TIREURS DE VILLE SAINT-PIERRE (hereafter referred to as the Club) for the purpose of carrying on together the sport of responsible gun ownership, handling and shooting in a safe environment, namely Le Club de Tir de Ville Saint-Pierre.

2. START OF MEMBERSHIP

The MEMBER is accepted upon the approval of the board of directors or its representative.

3. TERM

MEMBERSHIP, once approved is valid for a period of one (1) year or until determined by the board of Directors.

4. PRINCIPAL ESTABLISHMENT

The principal establishment of the Club will be located at 185 rue Camille, Ville Saint-Pierre, Quebec, H8R 1G7 and may be changed by the consent of the Board of Directors.

6. MEMBERSHIP FEES

The Membership fees of each member to the MEMBERSHIP consists of the following:

6.1 Membership fees of per year, for the current year of 1999, payable immediately upon the approval of the membership, which fees are made payable directly to Le Club de Tir de Ville Saint-Pierre.

6.2 The MEMBERS undertake to furnish additional contributions when required by the majority of the MEMBERS, to pay for any additional expenses and special events as may from time to time occur.

7. MANAGEMENT

The affairs of the CLUB will be managed by a Board of Directors who shall at all times be constituted by Marco Pendenza, Massimo Viviani, and Luigi Arena and/or their nominees, who will have the power of full administration as regards both the movable and immovable property of the CLUB.

8. DIVISION OF CAPITAL

It is not the intention of the members for the Club to have any profits and/or losses, and for this reason the Club shall not receive any funds other than those directed to the Club de Tir de Ville Saint-Pierre, which shall provide the services, location and environment for the practice of the Club's activities in exchange of these funds. Any capital at the dissolution of the Club shall be remitted to a recognized Charity as chosen by the Board of Directors.

9. WITHDRAWAL

9.1 In the event of withdrawal from the Club before the expiry of the annual membership, the member cannot ask for a reimbursement of any fees, unless the Board of Directors has asked that the member withdraw from the Club.

9.2 For the purposes hereof any Member is deemed to withdraw from the Club, who:

a) refuses or neglects, without valid reason, to strictly adhere to the rules and regulations of the Club and those of the Club de Tir de Ville Saint-Pierre or as they may from time to time be modified;

b) is found guilty of theft, fraud or embezzlement against the Club;

c) does anything directly or indirectly to demean the purposes of the Club or causes it serious prejudice;

d) refuses or neglects to comply with any of the obligations stipulated by these presents and does not correct this fault within ten (10) days of the receipt of any notice given by the Board of Directors advising him of the fault.

I, the undersigned, hereby declare having read the present membership agreement, agree to abide by the rules and regulations herein contained and as contained in a copy of the Club rules and regulations that are given to me as well as any rules and regulations that may be added, modified or removed from time to time, and also agree to abide by all the rules and regulations of the operator of the premises in which the Club exercises its activities. I also agree to always act reasonably and responsibly, while on the premises.
